Meeting Minutes September 10, 2025 12:00 p.m.

- 12:00 Welcome and Opening Comments Dana Charlton Value statement - We want a faithful representation of the work that we do and conversations we have in the meetings. - 12:05 <u>Storyteller</u> Janet Maine was unable to attend today's meeting as she is out of town celebrating the arrival of a new baby in her growing family. We look forward to reconnecting when she returns.
- 12:15 **SDMNO Updates** Alicia Hopkins expressed deep appreciation for her Direct Support Professionals (DSPs), highlighting their commitment to person-centered practices by supporting her autonomy in decision-making. She shared her DSPs actively communicated with her broader support team to ensure she could make her own dietary choices and expand her options, reinforcing her right to self-determination.

Progress continues on the youth-led video initiative focused on supported decision-making. The latest video was filmed during the July 10th meeting of the Youth Advocacy Council for OCECD and features Micheal Uher. We also connected with the director of the National Youth Voice Youth Choice Organization, who shared that similar videos have been produced nationwide and expressed enthusiasm about collaborating with us.

Outreach efforts are underway: we contacted 12 youth voice representatives from the provided list, and 5 have responded so far. Additionally, Josh received a response from another individual and will forward their information to Dana.

12:20 - <u>SDMNO Study/Survey Update</u> – Jeanne Novak
Jeanne is preparing to launch a statewide survey in Ohio, with distribution anticipated in October or November. Once finalized, she will share the link

for broader dissemination. The research explores key questions such as: What information do individuals receive about guardianship and its alternatives? What types of support help them make informed decisions? The project is funded by the U.S. Department of Health and Human Services through the Administration for Community Living and aligns with ongoing advocacy for supported decision-making in Ohio. To increase accessibility, QR codes and iPads will be available for on-site survey completion at the Synergy Conference.

Alicia Hopkins is contributing original artwork to serve as a visual backdrop for the survey display at Synergy, adding a creative and person-centered touch to the initiative.

In addition, Alicia will be showcasing her artwork in Cincinnati with a dedicated exhibition on October 10th. She is currently preparing the flyer, which will be posted on her art page. The Ohio Family and Guardians Network will also share the event link to help promote the show.

- 12:25 Strategic Plan and Next Steps <u>Breakout Rooms:</u> Update & Review of SDMNO Strategic Plan: Go to https://www.sdmno.org/ for the strategic planning progress report document lower left corner at the very bottom of the web page.
- Internal-Financial How do we develop greater capacity and adequate funding? Josh, Dana, Derek
 - Rather than pursuing formal membership structures, the group is exploring a
 model where organizations can become *supporting partners* contributing at
 various financial levels and having the option to display their logo in
 alignment with "Friends of SDMNO." This approach offers flexibility and
 visibility while fostering broader coalition support.
 - A range of grant possibilities were discussed, including the precedent of APSI receiving an Arts Council grant. SDMNO may be eligible to apply for similar funding, which could be a promising avenue. Additionally, storytelling around supported decision-making (SDM) was emphasized as a powerful tool and these narratives should be actively shared to build awareness and impact.
 - No new developments on Senate Bill 35 at this time.
 - Progress on the website remains on hold until sponsorship or monitoring support is secured.
 - A bank account is now established. The next step is determining how to collect donations and ensure they are deposited directly into the account. This requires identifying individuals or systems to manage the process.
- Outreach How do we extend our reach to targeted audiences? Amy, Lisa, Catie
 - Update the website We're seeking someone to assist with website updates for approximately 3–5 hours per month. This could involve the candidate attending the next meeting. Brendan Hamilton and Courtney Hineman have been identified as potential candidates. Additionally, Hadia will share contact information for another individual in Hamilton County to Amy for follow-up.

- o DD & D session is scheduled in Summit County, September 24th.
- Jeanne stated attendees can complete the previously addressed survey at the Synergy Conference. A QR code will be provided.
- Derek Graham will be presenting in OACB's SSA track this year. He will not be providing updates on the guardianship role. However, he will be providing updates on Supported Decision Making in Ohio, covering the basics.
- <u>Learning and Growth</u> How do we as a network continue learning and growing? Renee', Carolyn, Jason, Celia,
 - It was previously recommended that the Bill of Rights be included as a resource on the SDMNO website. However, given that version is now outdated, the site should be updated to incorporate additional foundational materials, including the Fair Housing Act (FHA), the Olmstead decision, and Section 504 of the Rehabilitation Act. These resources offer more current and comprehensive protections relevant to supported decision-making.
 - Angie shared the agency resource form she had previously created and distributed to the group. We reviewed the form and made updates to reflect current contacts and offerings. - Jessica will be distributing the People First language document to support inclusive communication.
- Alicia, who uses assistive technology herself, is interested in connecting
 with families and self-advocates who also use alternative communication
 devices. Her goal is to build outreach and community among those
 navigating similar experiences.
