 - o Angela Thomas stated she will share this survey form with her county board staff at their weekly meetings. Other areas where this can be shared is the PeopleFirst and Project STIR websites. Tom Hess said he would share with his list serves. Suggestions included writing a little bit about why you're requesting this and share using common language.
 - The storyteller video next month will be Lelise Kate Thornton, using a communication device.
 - Dashiell's video highlighted SDM because he recognized the need for support in reviewing documents before signing.
 - Josh was invited to a Transition Expo in Cincinnati, but he didn't have the time or have a coordinated effort to be at these events.
 - O Angie Chapple stated there are state support teams teaching individuals about SDM, talk about it with their families, and empowering them to make their own decisions at a younger age. The ODEW are is having discussions with families about alternatives to guardianship, such as SDM. Tom said of those agencies ex. (ODEW, DD, OOD, ODMHAS, ODJFS, ODM) Employment First can make a unified approach to have them all at the table with the same SDM information.
 - Questions of where do families find out about guardianship and how do they get information? Angie Chapple explained in school transition meetings they discuss transferring of guardianship. Jeanne noted that many transition specialists come from teaching backgrounds and often lack the necessary resources to fully support youth and families. While perhaps one in ten may have access to adequate tools, this gap represents a significant opportunity for infrastructure development.
 - Angela Thomas has been publishing updates to the SDMNO website and her assistance with this has been beneficial and greatly appreciated.
